Exhibitor Fees:

Business Exhibitors: \$150

Non-profit (501c organizations): \$75

Not-for-profit organizations with a mission to service the disability community / Presenting, Kids Zone, Gold, Silver, & Bronze Sponsors: Free

What is Provided:

Approximately 10x10 booth space in either an aircraft hangar or under the aircraft canopy. Outside space is also available for those desiring a location for a pop-up tent.

Electrical connection upon request (\$25 extra – limited availability)

What to Bring:

Table and chairs

Extension cord (if electric has been requested and confirmed)

Pop-up 10x10 tent with at least 40lbs of weight for each leg (if an outside location is desired)

All exhibitor materials

Set-up / Tear Down:

Set-up will be available from 4 pm – 7 pm on Friday, August 3 and from 7 am – 9 am on Saturday, August 4.

During that time, you will be able to drive your vehicle onto the airport ramp and unload near your booth space. After 9 am on Saturday, you will be unable to drive your vehicle onto the ramp and must carry any materials from the parking area. We ask that you don't tear down until the end of the event at 2 pm on Saturday, August 4.
